

# Terms & Conditions / Cookies

**Please review these terms and conditions carefully, as by using our website you agree to adhere to them.**

## **Privacy**

Leeder Safeguarding is committed to protecting your privacy. We will process your data in accordance with the Data Protection Act 1998 and the Privacy and Electronic Communications (EC Directive) Regulations 2003.

## **Are we a Data Processor or Data Controller?**

If you are using our services as an individual, you contacted us directly to enquire/purchase our services for your own personal use, we act as a Data Controller as per the GDPR definition.

If you are using our services as part of an organisation, i.e. the organisation purchased the services for their members/staff, then we act as a Data Processor as per the GDPR definition.

## **How we collect and use the information we receive from you**

We collect information about you when you contact us, register with us or place an order for products or services. We also collect information when you voluntarily complete customer surveys, provide feedback and participate in competitions. Website usage information is collected using cookies.

In particular:

- If you contact us by email or telephone, the contact details you provide and the details of the communication will be recorded and stored.
- If you engage with us online via our website, our cookies (see our Cookie Policy below for further information) and similar technologies will capture your IP address, your location, and record how you use the site to help improve it and improve your user experience, where your browser settings or permission allows for this.
- If you post information online about us, provide feedback or a review, we may keep a record.
- If you use our Live Chat service to communicate directly with us, we may collect personal data such as name, email address and phone number. Our LiveChat platform is provided by a third party.
- Customers can request a transcript of their LiveChat session when prompted at the end of their chat.

Your personal information will then be used by us to provide you with the services you ordered and from time to time to communicate with you on any matter relating to the provision of the services and to tell you about other services we provide. We will only use your data in ways you would reasonably expect and will not share your personal information with any third party, except where required by law. The legal basis for



using your data in this way is 'Legitimate interest' as it is necessary for us to run our business effectively and necessary for you, as the customer, to be able to receive and use the services we provide.

Individuals who receive correspondence from us such as newsletters, updates, resources and marketing will always be given clear information about how to 'opt out' of future contact via a simple to use Unsubscribe link. ### **Financial data**

When purchasing services from us payment is made through invoice, details of payment terms and conditions are outlined on the order Form or Contract Agreement. No banking or payment details are recorded or retained by us.

### **How we protect your data**

We know how important data security is to all our customers and we will treat your data with the greatest care and take all appropriate steps to protect it, including:

- We secure access to all transactional areas of our websites using 'https' technology.
- Access to your personal data is password-protected
- We regularly monitor our system for possible vulnerabilities and attacks
- Our website and related data is held securely in data centres

### **Access to your information and correction**

### **Cancellation / Refund Policy**
